AND FEE NOTICE OF COSTS AND EXPENSES

PURSUANT TO THE Preliminary Injunction entered on June 13, 2012 [Doc. 16], Jeanne B. Bryant, Independent Fiduciary for Retirement Security Plan & Trust (RSPT) submits this Report and Notice for the period beginning September 1, 2019 to September 30, 2019.

I. ACTIVITY REPORT

ADMINISTRATIVE FEE COLLECTIONS

The Independent Fiduciary ("IF") informed the Sponsoring Employers of the current status of their individual collections involving payment of the monthly administration fee. Attached as **Exhibit 1** are reports noting the collections and payments made from the account for previously approved fees and cost through September 30, 2019. The Independent Fiduciary will continue to collect any unpaid monthly administration fees using the same process previously approved by the Court. Most of the work in September involved continuing the process for terminating the Plan. It is anticipated there will be heightened administrative activity for the next several months as a result of the termination process. Billings for administrative fees for the month of September 2019 are the last invoiced monthly administrative fee billing. All plans are required to pay a termination fee of \$500.00.

PLAN TERMINATION ACTIVITIES

The IF received 39 completed Employer Withdrawal from Participation in RSPT forms on or about August 15, 2019. This constitutes the employers who remain in business. Based on these forms, 30 sponsoring employers are terminating their plans and 9 have or are creating successor 401K plans.¹

Since the majority of employers are terminating their 401K plans, nearly 300 participants received a blackout notice and distribution form. The blackout period is set to begin October 1, 2019. All forms were sent certified mail in compliance with the field assistance bulletin issued by the Plaintiff addressing missing participants.

¹ For those plans whose employer sponsor failed to submit a Withdrawal From Participation in RSPT form, those plans are being deemed abandoned by the IF and all participants in those plans are receiving a distribution form.

For those employers creating successor plans, employees who are currently employed will have their retirement accounts transfer to the successor plan. Those employees received notice of the successor plan and the blackout period. Those employees no longer employed by the sponsoring employer received a blackout notice and a distribution form. The IF and staff have been very busy coordinating with successor plans the deconversion and transfer.

As the Plan largely consists of participants holding qualified employers securities (QES), a great deal of time is involved in the transfer of these certificates. Regardless, the IF remains committed to the full distribution of the Plan by year's end.

ASSET RECOVERY EFFORTS

All of the Asset Recovery efforts concluded in May, 2019 and these efforts' results, and the decisions on which recovery actions were not taken, are fully discussed in the Notice to Terminate filed in July of 2019. (Docket No. 161)

II. ANTICIPATED FUTURE ACTIVITIES AND RESOLUTION OF ISSUES

As the Plan is currently being terminated, all of the activity will be focused on processing distribution forms and executing the necessary funds transactions to carry forth the directions of the participants. It is anticipated that all plan assets will be distributed by the end of plan year 2019 (12-31-2019). As such, one additional plan audit and one final Form 5500 will be filed as soon as possible. IRS Form 1099 reporting will be done by Aspire Financial for those mutual funds investments; the IF will be handling the IRS Form 1099 reporting for Qualified Employer Securities transfers/rollovers. These compliance and form filings will constitute the last actions required of the Independent Fiduciary.

III. ACCOUNTINGS REGARDING THE RSPT PLANS

As noted in Section 18 of the June 13, 2012 Preliminary Injunction, before causing the RSPT Plans to pay compensation, fees or expenses, the IF is to provide written notice (the "Fee Notice") of such compensation, fees or expenses, by filing the Fee Notice (such as set forth herein) with the Court, and by serving a copy of that filing to the Secretary of the U.S. Department of Labor, Employee Benefits Security Administration, Hutcheson and HWA. The IF intends to submit her Fee Notice and Activity Report on a monthly basis. If, within fifteen (15) days after filing of a Fee Notice, no objection to the Fee Notice, nor to payment by the Plan of the compensation, fees or expenses described therein, is filed with the Court, such compensation, fees or expenses shall be deemed reasonable expenses of the RSPT Plans and shall be paid by the RSPT Plans without further action or approval of the Court. The fees and expenses will be allocated as outlined above. In an effort to reduce costs, copies of this Report and Fee Notice are being posted to a website of the IF's company Receivership Management, Inc. ("RMI") and the participating employers will be given notice of the filing.

Attached hereto as **Exhibit 2** is a schedule of the hourly rates for the Independent Fiduciary and the hourly rates of any staff of Receivership Management, Inc. that might be used to carry out the terms of the Court's June 13, 2012 Preliminary Injunction.

Attached hereto as **Collective Exhibit 3** are expense summaries for the period of September 1, 2019 to September 30, 2019.

Total expenses, as listed on **Collective Exhibit 3** include \$2,346.00 in IF fees, \$375.00 in legal fees, \$8,492.00 in accounting services, \$12,068.10 in contract labor and \$1,409.77 in expenses (which may include ERISA bond payment, court costs and identified charges for other fees, postage, copies, telephone, travel, etc.) for the period of September 1, 2019 to September

30, 2019. Please note that counsel have, as necessary, redacted exact descriptions of litigation issues in order to protect applicable privileges, and the IF may also redact the names of employers and or members as to protect the companies or the members involved when responding to individual questions if required. The IF believes that the remaining descriptions are sufficient for approval of the charges requested.

In the absence of any objection, total reimbursement for \$2,346.00 in IF fees, \$375.00 in legal fees, \$8,492.00 in accounting services, \$12,068.10 in contract labor and \$1,409.77 in expenses for administration and litigation will be paid from the Plan's expense reserve in accordance with the Court's June 13, 2012 Preliminary Injunction. 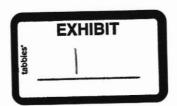
