INDEPENDENT FIDUCIARY OF THE GEORGIA PLUMBERS TRADE ASSOCIATION  
HEALTH PLAN PROPOSED PLAN OF DISTRIBUTION

---

Pursuant to the November 21, 2008 Order of this Court (D.E. # 107), Jeanne Barnes Bryant was appointed as Independent Fiduciary (hereafter referred to as "Independent Fiduciary") for The Georgia Plumbers Trade Association Health Plan (hereafter referred to as "the Plan"), to carry out the terms of the Order. Pursuant to this Order, the Independent Fiduciary submits this Plan of Distribution.

Background

This action was commenced by the Secretary of Labor pursuant to her authority under the Employee Retirement Security

Act of 1974. As a result of the Secretary's action, an order appointing the Independent Fiduciary was issued by this Court. On January 14, 2009, the Independent Fiduciary received documents and records from the U.S. Department of Labor, Employee Benefits Security Administration (EBSA). Among other documents were copies of letters from American Benefit Administrative Services, Inc., (ABAS) the Plan's former third-party administrator, sent to 252 plan participants reflecting 1,314 claims for unpaid medical services that ABAS had not processed or paid. Additional information was also provided reflecting census information, the amount of annual premiums paid and the total number of participants who were in the Plan between 2001 and 2004 (approximately 356 participants). See Exhibit 1. A total of \$250,000.00 was received by the Independent Fiduciary for the Plan and was placed into an account established for the Plan and the account is maintained at Regions Bank, a large regional FDIC insured financial institution.

Upon receipt of the documents and records from the U.S. Department of Labor, the Independent Fiduciary, through her staff, began attempting to locate electronic claims information, to include prior claims and deductible history for the participants necessary to processing claims under the Plan's terms of coverage. Contact was made with ABAS who advised that they no longer maintained any electronic information relating to the Plan nor did they have any prior claims history to provide to us. Requests for similar information were sent to Georgia

Plumbers Trade Association for Continuing Education and on February 3, 2009, it provided to the Independent Fiduciary electronic versions of the census data and premiums information already received in paper form from the U.S. Department of Labor.

After a review of the information provided and the lack of electronic claims information, the Independent Fiduciary, through her staff, began creating a database of plan participant information, provider information and unpaid claims information drawn from the letter issued by ABAS to the participants. The claims information has no medical supporting documentation. It does provide the name of the provider, the patient name, the participant's name, the unadjudicated claim amount, and the date the medical service was provided. While a provider name has been given, neither provider contact information nor provider tax id numbers were provided from any source. A copy of the database is attached hereto as **Exhibit 2**.

#### Status of the Plan

At this time, the Independent Fiduciary advises the Court that all possible collections of funds have been made. As indicated in **Exhibit 2**, a total of \$640,078.71 in unadjudicated unpaid claims has been reported.

In considering the fairest method of distributing the small amount of funds to the members who have outstanding claims owed to providers, a number of factors must be considered.

First, it is unclear as to who may still be owed money from the Plan. Second, no providers have been contacted by the Independent Fiduciary, no contact information is currently available to the Independent Fiduciary, and only one provider, through its counsel has contacted the Independent Fiduciary. Third, internet searches of providers may not be successful and, without confirmation of accuracy, may cause information, subject to the privacy provisions of the Health Insurance Portability and Accountability Act to be misdirected in violation of those information protections.

Fourth, because prior claims history is not available to the Independent Fiduciary, accurate claims processing is not possible. In order to have accurate claims processing, the Independent Fiduciary would have to have prior claims history so as to know if co-payments and deductibles have been met in order to accurately calculate the payment due.

Fifth, a pro-rata payment can be made to all members of the Plan who were paying premium at the time of the appointment of the Independent Fiduciary. This would be administratively easy, but might not result in payment to all members with outstanding claims.

Sixth, a pro-rata payment might be made to all members with claims over a certain dollar amount, such as \$10,000, on the assumption smaller claims are more easily handled between the members and providers, and may have already been resolved in some manner.

Seventh, a pro/rata payment might be made to only those members who received letters from ABAS. This too might be administratively easy, but may leave other member/participants with outstanding claims unpaid and would also leave out providers who may have unreported but unpaid medical claims for services to participants/members of the Plan.

#### Proposed Distribution Plan

After considering these options, both in order to expend the smallest amount of administrative funds, and to make the most impact in distributing the funds available, the Independent Fiduciary is making the following recommendations to the Court.

1. The Independent Fiduciary intends not to hire local counsel in order to save fees and reduce costs.
2. The Independent Fiduciary intends, upon approval of this Plan of Distribution, to issue notices to all 500 participants updating them as to the status of the plan and requesting from participants contact information for providers from whom they have received services (The Provider Contact Information Form attached hereto as **Exhibit 3**). For those participants for whom the Independent Fiduciary has unpaid claim information, a listing of unadjudicated claims will be sent. The Independent Fiduciary intends to give the participants 45 days within which to return the Provider Contact Information Form.
3. For those providers the Independent Fiduciary has received contact information for, the Independent Fiduciary will issue a Proof of Claim Form, with instructions for its

completion, along with any unpaid claim information available to the Independent Fiduciary. For those providers the Independent Fiduciary has not received contact information, the Independent Fiduciary will attempt to locate an address and issue a Proof of Claim Form as quickly as possible. In addition, every participant will also be issued a Proof of Claim Form, with instructions for its completion and return. As a part of this process, the Independent Fiduciary recommends a Proof of Claim filing deadline of December 10, 2009.

4. Because the Plan's coverage design paid, after subtracting copayment and deductible amounts, 80% of an in-network discounted billed charge or 50% of an out of network charge, the Independent Fiduciary intends to process and approve 52% of a submitted charge that is found to be for a legitimate medical service covered under the Plan's benefit coverage. In her experience, this gives effect to required copayment and deductible amounts and discounts usually taken.

5. As soon as practical after the recommended Proof of Claim filing deadline of December 10, 2009, the Independent Fiduciary will issue Claims Determination Statements to all persons who have filed a Proof of Claim Form. Persons receiving a Claims Determination Statement will have a sixty (60) day time frame from the date of the Statement's issuance within which to object and request reconsideration of the Independent Fiduciary's claim determination. The Independent Fiduciary will respond to

any request for reconsideration within thirty (30) days of receipt of such request.


6. After considering objections to any claim payable amount determined by the Independent Fiduciary, the Independent Fiduciary will file a Motion with the Court asking for authority to distribute all available funds. This Motion will contain the Independent Fiduciary's recommendations on claims. Also as a part of this Motion, the Independent Fiduciary will submit to the Court any claimant whose claims remain in dispute (including any late filed claims), along with a recommended procedure for the Court to consider claims remaining in dispute. Upon Order of the Court, the Independent Fiduciary will distribute assets accordingly.

7. Upon completion of the distribution of assets, the Independent Fiduciary will file a final accounting with the Court advising as to the distribution, and asking for discharge after performance of all responsibilities.

The Independent Fiduciary intends to issue notice of this Proposed Plan of Distribution to all known participants of the Plan by post-card and posting of this proposed plan on Receivership Management Inc.'s website at [www.receivermgmt.com](http://www.receivermgmt.com) and give them thirty (30) days to submit any objections to the Court. Notice will also be given to the one provider that has contacted the Independent Fiduciary, as well as the parties in this case.

Assuming that no objections are received and the Court accepts the recommendations of this plan, the Independent Fiduciary will issue Notices to each member with a forty-five (45) day deadline to return the Provider Contact Information Form. As soon as practical after the deadline for filing the Provider Contact Information Form, the Independent Fiduciary will issue the Proof of Claim Forms to participants and providers.



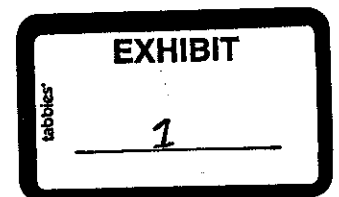

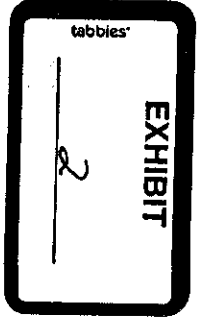
