**PROPOSED ORDER GRANTING SPECIAL DEPUTY RECEIVER'S
 MOTION TO AMEND
 PUBLICATION SCHEDULE FOR BIDDING NOTICE**

With the Special Deputy Receiver having filed a Motion on July 26, 2017, seeking to amend the provisions of the Court's July 12, 2017 Order governing publication of the court-approved bidding notice for the proposed sale of Hawkins County Memorial Gardens ("HCMG"), and with Defendant, Vickie Ringley, having been served with written notice scheduling a hearing on said Motion to occur on August 11, 2017 and advising Defendant of the necessity of filing and serving a response within the time requirements established by Local Rule § 26.04 to avoid having the Motion granted by the Court without a hearing, and with no response to the Motion having been timely filed or personally served by Defendant in compliance with Local Rule § 26.04, and with good cause having been shown, it is hereby:


ORDERED that the Special Deputy Receiver's Motion is **GRANTED**. Accordingly, the Nashville Tennessean shall be removed from the list of newspapers in which the HCMG bidding notice will be published. Further, the HCMG bidding notice shall be published in (1) the Kingsport Times for three (3) consecutive Sundays prior to the September 29, 2017 bid submission deadline, and (2) the Rogersville Review once a week for six (6) consecutive weeks prior to the September 29, 2017 bid submission deadline.
