**ORDER**

AND NOW, this 16<sup>th</sup> day of October, 2024, upon consideration of the Sixth Motion for Fees of Independent Fiduciary filed by Receivership Management, Inc., as a court-appointed independent fiduciary in this action, (“RMI”), and no objections having been filed to the payment of the fees and expenses charged by RMI and its service providers in the

Independent Fiduciary's Sixth Notice of Fee Filing [Dkt. 116] and Seventh Notice of Fee Filing [Dkt. 117], it is HEREBY ORDERED that the Clerk of Court is directed to withdraw from the remaining principal of the CRIS deposit of \$42,603.39 an amount equal to \$22,552.66, without interest. It is further ordered that \$22,552.66 will be paid to Receivership Management, Inc., at 510 Hospital Drive, Suite 490, Madison, Tennessee 37115, who shall be responsible for disbursement of the fees and expenses described in the Independent Fiduciary's Sixth and Seventh Notices of Fee Filing [Dkt. 116 and 117] to its service providers. Receivership Management, Inc. has completed a W9 form, which is on file with the Clerk's Office Finance Department. The remaining principal of \$20,050.73 and all interest will remain invested until further Order of Court.
